

## LOG BOILER SERVICE

### Up to 50kW

1<sup>st</sup> November 2019. See notes overleaf.

Services are recommended annually. The boiler must be cold when serviced and therefore should be turned off a minimum of 3 hours before servicing. It is essential that customers have the flue swept annually, and preferably prior to a service.

### Standard service

£324 + VAT including:

- ✓ checking boiler settings, performance and fuel consumption
- ✓ checking expansion vessel
- ✓ cleaning boiler
- ✓ cleaning out bottom section of flue below boiler
- ✓ stripping down heating surface cleaning mechanism
- ✓ performing actuator tests
- ✓ taking fluid sample for testing (where applicable)
- ✓ servicing pressurised domestic hot water cylinder (where applicable)
- ✓ one engineer for up to 4 hours

*Cleaning times can vary, typically due to the level of customer maintenance and the type of fuel being burnt, (eg. Soft woods can cause more tar).*

- ✓ travel for properties up to 50 miles from office
- ✓ parts and additional labour within warranty
- ✓ solar service discounted by £58, if serviced in the same visit

1<sup>st</sup> November 2019

### **Note 1.**

Pressurised (unvented) domestic hot water systems (where installed) should be maintained by a 'competent' person. This is recommended by Building Standards and most likely your house insurer. You may have a local plumber who is able to do this for you, or Glendevon Energy can offer the service where we installed the hot water tank.

### **Note 2.**

Additional charges to the Service Cost will be made for:

- Additional parts
- Additional labour at £58 + VAT per engineer per hour
- Travel at £1.21+VAT/mile each way over 50 miles from Head Office
- roof access (if required)
- telephone support at £50 + VAT per hour
- Office based trouble shooting & administration time at £50+VAT/hr, incl:
  - liaising with suppliers for product/ system/ warranty information
  - sourcing replacement and/ or warranty parts.

### **Note 3. Warranties.**

We are happy to remedy any problems relating to parts and labour installed by Glendevon Energy within warranty free of charge.

For installations, Glendevon Energy's warranty on parts and labour is typically 2 years from date of commissioning, manufacturer's warranties vary between systems. See terms and conditions of original sale. For repairs, Glendevon Energy's warranty on parts and labour is for 1 year unless it is a 'wear part' which manufacturers do not offer a warranty on.

For parts outside Glendevon Energy warranty, claims to manufacturers can be made for an administration charge of £55 + VAT, plus any expenses such as carriage. Replacement parts will be payable by the customer and refunded minus expenses if the claim is successful.

### **Note 4. Standard VAT is 20%.**
